Breast Cancer Awareness Month:

The Need for Inclusivity in Breast Cancer Clinical Trials

October is Breast Cancer Awareness Month, an annual campaign focusing on the impact of breast cancer, mammogram screenings for early detection, the importance of patients having access to clinical trials for individualized treatment therapies, and advancements in breast cancer research.

Considering survival rates for breast cancer have significantly increased due to continuous improvements in mammogram screening for early detection and treatment, breast cancer clinical trials are underrepresented in racial and ethnic diversity, causing racial disparities in breast cancer to persist, especially among women from racial and ethnic backgrounds (Adams et al., 2012). For example, non–Hispanic Black women have a higher risk of developing aggressive types of breast cancer and suffer from poorer outcomes compared to non–Hispanic white women (Clarke et al., 2022). Additionally, non–Hispanic Black women have about a 40% higher breast cancer death rate compared with non–Hispanic White women, indicating a higher need for heterogeneity in clinical trial participation (American Cancer Society) (Loree et al., 2019) (Clarke et al., 2022). As research continues to highlight barriers to minority recruitment in clinical trials, such as socioeconomic status, lack of access, financial challenges, education, and time limitations, clinicians, leaders, researchers, patient advocates, and other stakeholders must now implement new practical strategies to recruitment in trials that focus on achieving health equity in breast cancer outcomes, survivorship, and treatment.

As an NCORP promoting the participation of African Americans and other underrepresented groups in NCI Clinical Trials through community engagement and patient support systems, we understand the critical need to collaborate with community health clinics, patient advocates, and stakeholders to form partnerships to address the racial differences in breast cancer outcomes as they relate to clinical trial participation and data.
